**MEMORANDUM OF ASSOCIATION
OF
GUJARAT THEMIS BIOSYN LIMITED**

- I The name of the Company is **"GUJARAT THEMIS BIOSYN LIMITED"**
- II The Registered Office of the Company will be situated in the State of Gujarat.
- III The objects for which the Company is established are:-

(A) THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED ON INCORPORATION ARE:-

1. To carry on the business of manufacturing Erythromycin Basic and its Salts such as Erythromycin Estolate, Erythromycin Stearato, Erythromycin Ethyl Succinate etc. through Fermentation process and or any other suitable process.
2. To carry on trade and business of manufacturing, producing, sterile repacking, formulating, producing, refining, processing, extracting, finishing, converting and developing (herein after called manufacturing including grammatical variations) all kinds and all forms of fermentation products, natural products, synthetic products, drugs, medicines, medicinal preparations and formulations, pharmaceuticals, medical wines, cosmetics, intermediates, chemicals feed applements, insecticides, pesticides, disinfectants, dyes and dyestuffs, essences, extracts, antibiotics, tranquilisers, fine chemicals, diagnostic, agents and intermediates, reagents and raw materials thereof and reagents for analysis of pharmaceuticals, chemicals cosmetics and other purposes and minerals and the derivatives and by-products (for the sake of brevity, hereinafter all the above collectively mentioned as "drugs, pharmaceuticals and chemicals")
3. a) To acquire from M/s. Chemosyn Private Ltd. all or any portion or portions of the land situated at the Industrial Area, Vapi, Gujarat held by them under the lease granted to it including plant and machinery, fixtures utilised for manufacture of Erythromycin (Basic Drug and Salts including tanks, boilers, offices, laboratories, store houses, godowns and to pay for the same at a price decided jointly by GIIC and M/s. Chemosyn Private Ltd. either in cash or by way of allotment of shares or debentures of this company and partly in one way and partly the other way.

b) To acquire from M/s. Chemosyn Private Ltd. its one or both of the undertakings situated at Industrial area, Vapi, Gujarat viz.

Erythromycin manufacturing unit and/ another fine-chemicals manufacturing unit together with ancillary structures and installations including boilers, tanks, stores, office, laboratory and other services and to pay for the same in cash or by way of allotment of shares in the company credited as fully paid up or issue of debentures in the Company or partly in one and partly the other manner.

4. To develop and/ or acquire technical know-how, recipes and information, technical data and information to manufacture and right to process and manufacture, one or more of the "drugs, pharmaceuticals and chemicals" and to enter into arrangements for use or acquiring proprietary rights of trade marks, patents etc. regarding the same.
5. To act as consultants in the field of manufacturing "drugs, pharmaceuticals and chemicals".
6. To take up contract work for setting up Turnkey Projects in the field of manufacturing of "drugs, pharmaceuticals and chemicals".
7. To carry on business as manufactures, buyers, sellers, distributors; selling or buying agents, stockiest, suppliers, indentors, commission agents, brokers and dealers in all kinds and all forms of "drugs, pharmaceuticals and chemicals",

(B) THE OBJECTS INCIDENTAL OR ANCILLARY TO THE MAIN OBJECTS OF THE COMPANY ARE :-

- (1) To start factories and other undertakings so as to further developments of chemicals, pharmaceuticals and other related industries in India and elsewhere.
- (2) To establish a well equipped laboratory and carry on analytical and preparative experimental and research work for promoting interest of the factories and other undertakings and objects of the Company in general.
- (3) To undertake and execute any contract for works involving the supply or use of any machinery or raw material and to carry out any ancillary or other works comprised in such contracts.
- (4) To manufacture, buy, sell, import, export or otherwise deal in containers of all varieties and descriptions, packing materials of every kind, as also in machinery and equipments required in or necessary for the purpose and to hire, let on lease, maintain, repair or service such machinery or equipment.
- (5) To establish, maintain, conduct, provide, procure or make available service of every kind including commercial, financial, social or other

services and to take such steps as may- be necessary for the purpose.

- (6) To receive money, raw materials, intermediates on de- posit or loan or for safe custody.
- (7) To carry on business of advertising contractors and agents and any other business which may be usefully carried on in connection with such business.
- (8) To encourage, organise, promote and participate in exhibitions, trade fairs, competitions, demonstrations of any kind or variety, cinema or dramatic shows for the promotion of the business of the Company.
- (9) To purchase or otherwise acquire and let on hire rent or deal in land, houses, offices, workshop and premises and fixed and immovable machinery, tools, engines, boilers, plants, patterns, stock-in-trade, patents for manufacturing and business of the Company.
- (10) To raise or borrow or secure the payment of money in such manner and on such terms as may seem expedient and in particular by the issue of bonds, debentures or mortgages whether perpetual or otherwise and charged or not charged on the whole or any part of the rights or property and the undertakings of the Company including the uncalled capital and redeem, purchase or pay off any such security.
- (11) To make, draw, accept, endorse, negotiate discount, buy, sell and deal in bills, notes and other negotiable and transferable instruments or securities.
- (12) To receive on deposit with or without allowance of interest, to advance and lend moneys upon such securities or without any securities therefor as may be thought proper to any person, firm or company and to invest such of the Company's moneys not immediately required, in such manner as may from time to time be required and to guarantee in performance of any contract. Provided that the Company shall not do any banking business within the meaning of Banking Companies Act, 1949.
- (13) To develop or turn to account any land acquired by the Company or in which it is interested and in particular laying out and preparing the same for building purpose, constructing, altering, pulling down, decorating, maintaining, fitting, fitting up and improving, building and conveniences and by planting, paving, draining, farming, cultivating, letting on building lease and entering into contracts and arrangements of all kind with building tenants and others.
- (14) To acquire by concession, grant, purchase, barter, lease, licence or otherwise either absolutely or conditionally and either solely or jointly

with others any houses, lands, farms, water rights and hereditaments and any machinery, plant, utensils, trademarks and other movable and immovable property of any description in India or elsewhere in the world.

- (15) To pay for any properties, rights or privileges and technical know-how acquired by this Company either in shares of the Company or partly in shares and partly in cash or otherwise, and to give shares or stock of this Company in exchange for shares or stock of any other company.
- (16) To purchase or otherwise acquire and undertake the whole or any part of the business, property, rights and liabilities of any person, firm or company on any business which this Company is authorised to carry on or possessed of property or rights suitable for any of the purposes of the Company and to purchase, acquire, sell and deal in property, share stock, debentures or debenture-stock of any such person, firm or company and to conduct, make or carry into effect arrangements in regard to the winding up of the business of any such firm, person or company.
- (17) To enter into partnership or into any arrangements for sharing profits, union of interest, reciprocal concession or co-operation with any person, partnership or company and to promote, constitute, form and organise, and aid in promoting, constituting, forming and organising companies, syndicates or partnership of all kinds for all the purposes of acquiring and undertaking any property and liabilities of this Company or of advancing directly or indirectly the objects thereof or for any other purposes which this Company may think expedient. As also to pay for any properties, rights or privileges required by this Company either in shares of the Company or partly in shares and partly in cash or otherwise and to give shares or stock of this Company in exchange for shares or stock of any other company.
- (18) To apply for, purchase or otherwise acquire and protect, prolong and renew whether in India or elsewhere, any patents, patent rights, brevets, d'invention, licenses, protections, concessions and the like conferring any exclusive or limited right to any inventions, secrets or other information which may seem capable of being used for any of the purposes of the Company, or the acquisition of which may seem calculated directly or indirectly to benefit the Company, and to use, exercise, develop, manufacture under, or grant licence or privileges, in respect of or otherwise turn to account, any patents, patent rights, inventions, secrets or information so required, and to spend money in experimenting upon, testing, improving or seeking to improve the patents, patent rights, inventions, secrets or informations so required, and to spend money in experimenting upon, testing, improving or seeking to improve the patents, patent rights, inventions, secrets or informations so acquired or proposed to

be acquired.

- (19) To carry on any other business which may seem to the Company capable of being carried on in connection with above objects mentioned in this Memorandum or any of them or calculated directly or indirectly to enhance the value or render profitable any of the Company's property or rights.
- (20) To provide for the welfare of the employees (including Directors) or ex-employees of the Company or its predecessors in business and the wives, widows, and families of the dependents or connections of such persons, by building or contributing to the building of houses or dwellings or quarters or by grant of money, pensions, gratuities, allowances, bonuses, profit sharing bonuses or benefits or any other payments or by creating and from time to time subscribing or contributing to provident and other associations, institutions, funds, profit sharing or other schemes of trusts and by providing or subscribing or contributing towards places of instruction and recreation, hospitals and dispensaries; medical and other attendance and other assistance as the Company shall think fit.
- (21) To make donations to such persons or institutions and in such cases and either of cash or of any other assets as may be thought directly or indirectly conducive to any of the Company's objects or otherwise expedient and in particular to remunerate any person or corporation introducing business of this Company.
- (22) To subscribe or contribute or otherwise to assist or to guarantee money to charitable, benevolent, scientific, national, public, political or any other useful institutions, objects or purposes or for any exhibition.
- (23) To remunerate any person, firm or company for services rendered or to be rendered in placing or assisting to place or guaranteeing of any of the shares in the Company's capital or any debentures or debenture-stock or other securities of the Company or in or about the formation or promotion of the Company or the conduct of its business.
- (24) To create any depreciation fund, reserve fund, sinking fund, insurance fund or any other special fund whether for depreciation or for repairing, improving, extending or maintaining any of the property of the Company or for any other purpose conducive to the interests of the Company.
- (25) To amalgamate with any other company.
- (26) To distribute any of the property of the Company amongst the members in specie or kind, in the event of winding up.

- (27) To place or reserve or to distribute as dividend or bonus among the members or otherwise to apply, as the Company may from time to time think fit, any money received by way of premium of shares or debentures issued at a premium by the Company and any money received in respect of dividends accrued on forfeited shares and moneys arising from the sale by the Company of forfeited shares or from unclaimed dividends.
- (28) To accumulate capital from the profits of the Company for any of the purposes of the Company, and to use and appropriate the same or any of the Company's assets either conditionally or unconditionally to specific purposes, to accumulate funds and to admit any person or persons who have moral or legal claim to participate in the profits and assets of the Company.
- (29) To pay out of the funds of the Company all expenses of and incidental to the formation, registration, advertisements and establishments of this Company and the issue and subscription of the shares or loan, capital, including brokerage and or commission for obtaining applications for or placing or guaranteeing the placing of shares or any debenture, debenture-stock and other securities of this Company and also all expenses attending the issue of any circular or notice and the printing, stamping and circulating of proxies and forms to be filled up by the members of the Company.
- (30) To indemnify members, officers, Directors, Agents and servants of the Company against proceedings, costs, damages, claims and demands in respect of anything done or ordered to be done by them for and in the interest of the Company and for any loss, damage or misfortune whatever which shall happen in the execution of -the duties of their office or in relation thereto.
- (31) To do all or any of the above things in any part of the world either as principals, agents, contractors, trustees, or otherwise and either by or through agents, trustees, subcontractors or otherwise either alone or in conjunction with others and to allow any property to remain outstanding in such agents or trustees.
- (32) To carry on all kinds of promotion business, and in particular to form, constitute, float, lend money to, assist, and control any companies, associations or undertakings whatsoever.
- (33) To do all such other things as are incidental or conducive to the attainment of the above objects or any of them.
- (34)(a) To undertake, carry out, promote and sponsor rural development including any programme for promoting the social and economic welfare of, or the uplift of the people in any rural area and to incur any expenditure on any programme of rural development and to

assist execution and promotion thereof either directly or through an independent agency or in any other manner. Without prejudice to the generality of the foregoing, "Programme of rural development" shall also include any programme for Board of Directors consider it likely to promote and assist rural development, and that the words "rural area" shall include such areas as may be regarded as rural areas under section 35 CC of the Income tax Act, 1961, or any other law relating to rural development for the time being in force or as may be regarded by the Board of Directors as rural areas and the Board of Directors may at their discretion in order to implement any of the abovementioned objects or purposes transfer without consideration or at such fair or concessional value as the Board of Directors may think fit and divest the ownership of any property of the Company to or in favour of any Public or local Body or Authority or Central or State Government or any Public Institution or Trust or Fund established under any law for the time being in force or approved by Central or State Government or any authority specified in that behalf.

- (b) To undertake, carry out, promote, and sponsor or assist any activity for the promotion and growth of the national economy and for discharging what the Board of Directors may consider to be Social and moral responsibilities of the Company to the Public or any section of the public as also any activity which the Directors consider likely to promote national welfare or social economic or normal uplift of the people or any section of the people and in such manner and by such means as the Board of Directors may think fit and the Directors may without prejudice to the generality of the foregoing undertake, carry out, promote and sponsor any activity for publication of any books, literature, news- papers, etc. or for organising lectures or seminars likely to advance these objects or for giving merit awards, scholarships, loans for any other assistance to deserving students or other scholars or persons to enable them to prosecute their studies or academic pursuits or researches and for establishing, conducting or assisting any institution fund, trust etc. having any one of the aforesaid objects as one of its objects, by giving donations or otherwise in any other manner and the Directors may at their discretion in order to implement any of the above mentioned objects or purposes transfer without consideration or at such fair concessional value as the Directors may think fit and divest the ownership of any property of the Company to or in favour of any public or local Body or Authority or Central or State Government or any Public Institution or Trust or Fund established under any law for the time being in force or approved by Central or State Government or any authority specified in that behalf.

(C) THE OTHER OBJECTS FOR WHICH THE COMPANY IS

ESTABLISHED ARE :-

1. To carry on business of every kind, and to act as merchants, traders, commission or other agents, or in any other capacity whatsoever in India or elsewhere, to carry on the business of providing services of every kind, and to import, export, buy, sell, barter, exchange, pledge, make advances upon or otherwise deal in goods, produce, articles, merchandise, services, conveniences and amenities of every kind.
2. To carry on business as capitalists, financiers, concessionaries and merchants, and to undertake, and carry on, and execute all kinds of financial, commercial, trading and other operations, and to carry on any other business which may seem to be capable of being conveniently carried on in connection with any of these objects, or calculated, directly or indirectly, to enhance the value of, or facilitate the realisation of, or render profitable, any of the Company's property or rights.
3. To buy, sell, manufacture, repair, alter and exchange, let on hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the business of the Company or commonly supplied or dealt in by persons engaged in any business, or which may seem capable of being profitably dealt with in connection with any of the business of the Company.
4. To carry on any other business, whether manufacturing or otherwise which may seem to the Company capable of being conveniently carried on in connection with any of the objects of the Company.

AND IT IS HEREBY DECLARED THAT :-

- (i) The objects incidental or ancillary to the attainment of the main objects of the Company as afore- said shall also be incidental or ancillary to the attainment of the other objects of the Company herein mentioned.
- (ii) The word 'Company' (save when used with reference to this Company) in this Memorandum shall be deemed to include any partnership or other body or association of persons whether incorporated or not and wherever domiciled.
- (iii) The objects set forth in each of the several clauses of paragraph III hereof shall extend to any part of the world.
- (iv) Subject to the provisions of the Companies Act, 1956, the objects set forth in any clause of sub-paragraph (C) above shall be in no wise limited or restricted by reference to or in reference from terms of any of the clauses of sub-paragraph (A) or by the name of the Company.

None of the clauses in sub-paragraph (C) or the objects therein specified or the powers hereby conferred shall be deemed subsidiary or auxiliary merely to the objects mentioned in any of the clauses of sub-paragraph (A).

- (v) Nothing in this paragraph shall authorise the Company to do any business which fall within the purview of the Banking Companies Act, 1949 and the Insurance Act, 1938.

IV The liability of the members is limited.

V *The Authorized Share Capital of the Company is ₹25,00,00,000/- (Rupees Twenty Five Crores Only) divided into 25,00,00,000 (Twenty Five Crores) Equity Shares of ₹1/- (Rupees One Only) each with the power of the Company to increase or reduce from time to time its capital and to issue any shares in the equity capital and attach to any class of such shares any preference, right, privileges or priorities in payment of dividend or distribution of assets or other matter or to subject the same to any restriction limitation or conditions and to vary regulation of the Company as may be necessary to give effect to the same.
