- 8. You will be completing the maximum tenure available to an Independent Director under the current provisions of the Companies Act, 2013 as per point No. 2 above. However, depending on the statutory provisions and SEBI Guidelines prevailing at the time of completion of your tenure, the Board shall take appropriate decision on reappointment.
